Blue Cross and Blue Shield of New Mexico will begin providing Medicaid services to eligible New Mexico recipients through its BlueSalud and BlueSCI products. BlueSalud is a state funded managed care product and BlueSCI (State Coverage Insurance) is a state-employer combined managed care product.

Prime Therapeutics LLC will begin processing claims for members of BlueSalud and BlueSCI in New Mexico effective October 1, 2008. Members of BlueSalud and BlueSCI will utilize the Prime Therapeutics New Mexico Medicaid Network.
