Effective January 1, 2017 BlueCross BlueShield of Minnesota and Blue Plus (BCBSMN) will be utilizing a new Processor Control Number (PCN) for Medicare supplemental claims for Covered Persons of BCBSMN Medicare Supplement Plans including Senior GoldSM.
